

Go For Glow Recycling Contest Terms & conditions

- 1) The Go For Glow Recycling Contest is open to individuals aged eighteen (18) or over in the United Kingdom and the Isle of Wight (not available for the Isle of Man and the Channel Islands), however, the Promoter's employees, their families, their agents or anyone else connected to the contest are excluded from participating.

- 4) Prior to entering the contest, participants must have a TerraCycle account (created via the TerraCycle website https://www.terracycle.com/en-GB/account/sign_up) and have successfully joined all three of the participating programmes listed in point 3. To sign up to a programme, the participant must click on the hyperlinked programme above and read, then complete, the steps listed in the 'How it Works' section.
- 5) Participants will get a bonus of 200 TerraCycle points (£2) for the first shipment (respecting the minimum weight requirements) they send in the contest. Only applicable once.
- 6) To enter, participants must ensure they are a member (by setting up a public drop-off location or becoming a private collector) of all three participating programmes listed in point 3. Participants then need to collect the corresponding accepted waste for the recycling programme(s) they want to send waste for. Once enough waste to meet the minimum weight requirement has been collected, participants need to send the waste to TerraCycle® using a free shipping label accessible by logging into their TerraCycle® account, which can be found here:

- 7) Parcels weighing the relevant recycling programme's minimum weight (visible on the corresponding programme page on the TerraCycle website) and containing waste accepted in the corresponding participating recycling programmes, sent by **XX** will be accepted and counted as an entry.
- 8) The types of accepted waste are outlined on the individual programme pages (linked in point 3). Please note that waste from different recycling programmes can not be sent in the same parcel because the different waste types need to be kept separately for recycling purposes.

- 9) Each shipment sent will count as an entry in a sweepstake for a chance to **win £180 worth** of products from the brand(s) the participant has sent shipments.
- 10) Please note that TerraCycle is not responsible for any parcels that are lost or delayed in transit. Proof of posting is not proof of receipt.
